Public Works Zimmer discussed a grant for TOT park equipment presented to him by Southeaster Montana Mom's Club for \$3,000. The club is wanting permission for the grant from the Town and have the Town match would cover costs for concrete and rubber pad at \$1,500. The Council questioned if it would be structurally sound for the amount of abuse playground equipment gets. Denbury wants to purchase water from the Town for pipeline. PW Zimmer doesn't feel our streets can handle the number of loads that will be hauled. This project is still being discussed to see if its feasible. Have purchased some new dumpsters and will continue repairing the existing ones. Semi-Truck took out part of the park fence and it will need replaced. Stump grinder works great. Sidewalk grant has been split into two phases; if the project continues the Town match is estimated at \$19,128.00 phase one and \$11,761.00 for phase two. Exact amount isn't available at this time. Councilperson Wenzel moved to proceed with phase one sidewalk project. Councilperson Turnbough seconded the motion. Motion carried.

Public Works Ragsdale reported the Hill well will be pulled on Thursday; in order to pull well the roof needs to be removed, power rerouted and will put pulled pipe by the street. Once pulled the problem will be detected and plan for action will be done. The Town of Broadus will be receiving grant money for water and wastewater infrastructure for \$111,859.00; Raymond is working with SEMDC to see what all money is available for drilling a new well. Application is due July 1st and will be awarded in September.

Clerk Fruit reported the engineers for the lagoon project billed a invoice twice to SRF. Thus, the Town will have to repay this amount plus our regular payment in June.

Councilperson Wenzel move to approve the listed events pending proof of insurance. Councilperson Turnbough seconded the motion. Motion carried with all in favor.

Cassidy Zimmer and Roy Pilcher, Kois Brothers representative discussed the current solid waste truck and trade in value. The cost of a new truck with trade would be approximately 150K with the options to pay off in 5 or 7 years. Councilperson Morris moved to approve the purchase with 7 year pay off. Councilperson Turnbough seconded the motion. Motion carried with all in favor.

Public Works Zimmer reported on the signage that was available to event holder for sign in and out; some repairs to the sprinkler system in the park; tree trimming in the park; working on alleys; will be advertising for summer help; starting to patch streets and cleaning up some of the right of way. The sidewalk project will not be done due to the expense is not affordable at this time.

Public Works Ragsdale discussed the hill well new pump, wiring and flushing the line so that it will back on line; SEMDC will be helping to find money to drill a new well with a scada system. Public Works Wilson will be completing water and wastewater school online.

Councilperson Wenzel announced his resignation from the Council. Will begin the search for a new Council person.

Clerk Fruit will be completing classes online all of this week.
